# COP29 participants traveling from outside Azerbaijan will require a visa.

The Azerbaijan Government has authorized a 'COP29 Special Visa', free of charge, for all UNFCCC-registered participants. It is mandatory to apply for the 'COP29 Special Visa' prior to arrival in Azerbaijan, using the visa application link within the UNFCCC registration confirmation email.

Visit e-visa portal as soon as you receive the UNFCCC registration confirmation email using the link provided.

Enter UNFCCC registration number, date of birth and passport number.

Fill in e-visa application form and upload your passport copy (maximum 1MB, .jpg) and complete.

Once your e-visa is issued you will receive a link to download it.

Participants are strongly encouraged to apply for their e-visa as soon as they receive the UNFCCC registration confirmation email.

Passports must be valid for at least six months after the validity period of the e-visa being issued.

Participants must apply for a new 'COP29 Special Visa', following the same procedure, if they leave Azerbaijan during their stay and wish to return to the country to attend the conference. Please note that applicants can only apply for a 'COP29 Special Visa' after leaving Azerbaijan.
