#### **1. Introduction**

This Guide outlines the step-by-step procedure to register for media accreditation for the Green Zone at COP29. The <u>COP29 Green Zone Media Accreditation Portal</u> is the only official platform through which media can be accredited to the Green Zone.

The Guide has been compiled by the COP29 Azerbaijan Operating Company's (COP29 Azerbaijan OC) Media Accreditation team to assist media representatives in navigating the registration process for the Green Zone and to provide clear and concise information on requirements and necessary documentation.
