1. Introduction

The goods that will be temporarily brought to Azerbaijan must be declared via the <u>E-customs:</u> <u>Electronic Customs Services portal</u> at least **72 hours** prior to arrival in Azerbaijan:

- All media equipment that will be temporarily imported into Azerbaijan (both radioelectronic devices registered via the <u>COP29 Radio Spectrum Management Portal</u> and any other equipment not requiring spectrum allocation)
- Goods with a customs value over 800 USD
- Currency (if the amount exceeds the equivalent of 10,000 USD in cash)

When you arrive in Azerbaijan, you must present the following documents to the customs officer at the airport:

- Acknowledgement letter
- QR code from the <u>COP29 Radio Spectrum Management Portal (if you bring radioelectronic equipment)</u>
- Simplified declaration for passengers (hard copy or QR code)

Note: The declaration must be presented along with the declared goods to the customs officer upon departure from Azerbaijan.

2. Creation of a new declaration

To create a new declaration, visit <u>E-customs: Electronic Customs Services portal</u> and click **'+New'.**

Select 'Belonging to me', enter your citizenship, passport number (or PIN) and date of birth, then click 'Next'.

Note: Declare the goods using **the same document (passport or ID)** with which you are traveling. Passengers eligible to travel to Azerbaijan with an ID card can enter the **PIN**.

2.1. Declaration of goods

To declare the goods you plan to bring into Azerbaijan, select **'Yes'** in response to the question under the **'Goods'** category.

You may choose relevant goods under **'The most declared goods'** section or scroll down to the fields below to select specific goods.

For media equipment declaration, select **'Other goods'** from the **Main category** field, **'Media equipment'** from the **Main group** field and the specific equipment from the **Subgroup** field.

Next, enter relevant details (make, model, etc.) in the **'Description of goods'** field and indicate the cost, quantity and unit of the item being declared.

Note: If you are declaring multiple units of the same goods, please enter the total cost in the 'Cost of goods (USD)' field.

Since the goods are imported temporarily, select **'Temporarily imported/exported goods'** and provide the exact return date.

Note: If you select '**Temporarily imported/exported goods'**, you are required to return these items upon departure from Azerbaijan. The customs officer will impose a border crossing restriction once your declaration is approved. When you depart the country, proceed to the crossing point and present your declared items to the customs officer for the restriction to be removed.

After entering all the required information, click 'Add'.

After submitting the declaration, you are required to provide a photo of the declared goods. Click **'Add file'** and upload the photo of the goods.

Following the upload of the photo, either **print the declaration or download the QR code** to present to the customs officer upon arrival in Azerbaijan.
